**Saudi Arabia:** No longer requires legalization effective January 2008. However, legalization still offered by Royal Embassy of Saudi Arabia

**Argentina:** Legalized certificate of origin required, also Certification by a registered US chamber of commerce is a prerequisite to legalization.

Certificate of Origin:	\$ 40 per document.
Chamber of Commerce:	\$ 25 per document
WCS Fee:	\$ 60 per set

**Dominican Republic:** No longer requires legalization effective July 2006

**Guatemala:** No longer requires legalization effective December 2000

**Nicaragua:** No longer requires legalization effective 2003

**Panama:** Legalization is no longer required; however, shipments into the Colon Free Zone may require legalization. \$30.00 per document

**Paraguay:** Commercial invoice, certificate of origin and B/L or AWB required for legalization.

Consul fee:	\$ 70.00 per set
Additional documents:	\$ 33.00 each / \$45.00 C.O.
Copies of all documents:	\$ 4.00 each
WCS Fee:	\$ 40.00
WCS Special Handling:	\$ 20.00

*Shipping documents for Paraguay must be certified by a chamber of commerce within the jurisdiction of the D.C. Embassy of Paraguay prior to legalization*
